This notification is made by Finso Finansal Teknoloji Çözümleri A.Ş. in the capacity of Data Controller within the scope of the provisions of the Data Controller's disclosure obligation regulated in Article 10 of the Law on the Protection of Personal Data No. 6698 ("PDP Law").

## 2 COLLECTION AND PROCESSING OF YOUR PERSONAL DATA

**Your name, surname, e-mail address, the reason for your contact and the content of the message and the personal data you have forwarded to us**, your visitor information on the <https://finso.co.uk/about-contact> (or <https://finso.com.tr/about-contact> or <https://finsopay.com/about-contact>) website is obtained through the electronic form, and the personal data you enter in the contact form directed. The data is recorded through the software that processes the data in the database and processed in accordance with the principles specified in Article 4 of the KVKK in the ways specified in the Personal Data Inventory and our Personal Data Protection Policy.

## 3 PROCESSING OF YOUR PERSONAL DATA, PURPOSE AND LEGAL REASON

Your personal data mentioned above, to manage and carry out the services of the Company's main activity, to fulfill the contractual obligations of the Company, to improve the services of the company and the website by analyzing the data, to establish a right to provide faster and more effective service to those who fill out the contact form, Data processing is mandatory for the use or protection of data, Data processing is mandatory for the legitimate interests of the Data Controller, provided that it does not harm the fundamental rights and freedoms of the data subject.

## 4 TRANSFER OF YOUR PERSONAL DATA, PURPOSE AND LEGAL REASON

In order to fulfill our obligations regarding information and document sharing arising from the relevant legislation, as well as our other legal obligations, based on your personal data, the legitimate interest of the Data Controller, and the legal reasons that it is expressly stipulated in the laws; It can be transferred to "**Authorized Public Institutions and Organizations**" upon request.

Your Personal Data; Data processing is compulsory for the legitimate interests of the Data Controller, for the performance of the contracts we have made for the provision of necessary external services regarding our activities and for the fulfillment of the necessary transactions, but limited to this purpose, the establishment or performance of a contract, the necessity for the Data Controller to fulfill its legal obligations, It may be shared with "**Our Suppliers**" with whom we have a business relationship and from whom we receive services, based on legal reasons that data processing is mandatory for the establishment, use or protection of the right.

- For example, if **Your Name, Surname and Contact Information** are required for legal proceedings, the legitimate interest of the Data Controller is shared with **the Lawyers** from whom we receive legal services, based on the legal reason.



- In case the subject of your message concerns our Group Companies, the legitimate interest of the Data Controller for the purpose of informing them or for the fulfillment of the obligations in the Turkish Commercial Code and the provisions of the agreements made between the companies that are the subject of the Group of Companies or the companies in the Group of Companies, the establishment and performance of the contract, its stipulation in the laws, express consent is legal **Your Name, Surname and Contact Information** may be shared with "**Our Community Companies**" based on the reasons.
- Within the scope of our obligations to provide information and similar obligations arising from the Commercial Code and the provisions of the relevant legislation, especially the provisions specific to each company type in the section titled Commercial Companies of the Turkish Commercial Code (TTK, TCO and relevant legislation), it is mandatory for the Data Controller to fulfill its legal obligations **Your Name, Surname and Contact Information** may be transferred to real or legal persons, namely "**Shareholders**", who own shares (shares) in the Company of the Data Controller based on legal reasons.
- In case the subject of your message indicates a situation originating from our Business Partners, for the purpose of providing information or for the execution of the contractual provisions containing the commercial activities subject to the Business Partnership, and only limited to this purpose, based on the legal reasons of the establishment and performance of the contract, the legal obligation of the Data Controller, the legitimate interest of the Data Controller, Your Name, **Your Surname and Contact Information** can be transferred to "**Business Partners**."
- If your personal data that you share in your message or send to us with the form is the subject of e-mail, it is deemed to have been transferred abroad in accordance with Article 9 of the Personal Data Protection Law No. 6698, since our e-mail servers are abroad.

## 5 YOUR RIGHTS

To the extent that your data is processed by the Company and the Company processes your data as a Data Controller, you have the following rights in accordance with Article 11 of the Personal Data Protection Law No. 6698:

*"Learning whether any of your personal data is processed; requesting information regarding processing activities; learning the purposes of processing; learning these persons if they have been transferred to third parties in the country or abroad; requesting their correction if they are incomplete or incorrectly processed; to request the deletion or destruction of personal data in the event that the reasons for its processing disappear or the Company does not have a legal basis or legitimate interest to process the said data; Requesting the Company to ensure that third parties, also authorized by the Company, who process personal data respect your rights under this section; Objecting to adverse results that may arise as a result of processing personal data through automated systems, and; To request compensation for this damage in case you suffer damage due to unlawful processing."*

You can send your questions about your rights regarding the processing of your personal data in writing or by e-mail confirming your identity.



## 6 APPLICATION TO DATA CONTROLLER

You can submit your requests within the scope of Article 11 of the Law, which regulates the rights of the person concerned, in writing by personally applying to the physical address of our Company in accordance with the "Communiqué on Application Procedures and Principles to the Data Controller", through a notary public, by registered e-mail or by e-mail provided that your identity has been confirmed before.
